Carlson Wagonlit Travel Acquires Gateway Travel Management of Pittsburgh

With the purchase of Gateway Travel Management, CWT not only expands its presence in the Pittsburgh area but also furthers its established growth strategy, which includes increased growth in the small and medium enterprise (SME) market and targeted acquisitions, along with the sale of value-added products and services to new and existing clients.

GTM's expertise at serving SME clients in the Pittsburgh area will benefit CWT even further in this key market, noted Sam DeFranco, senior vice president of National Accounts for CWT North America. "I look forward to blending the Gateway team's considerable industry expertise and customer focus with ours," he added. "I'm also excited to meet CWT's newest employees and clients, and to personally welcome them to the organization."
